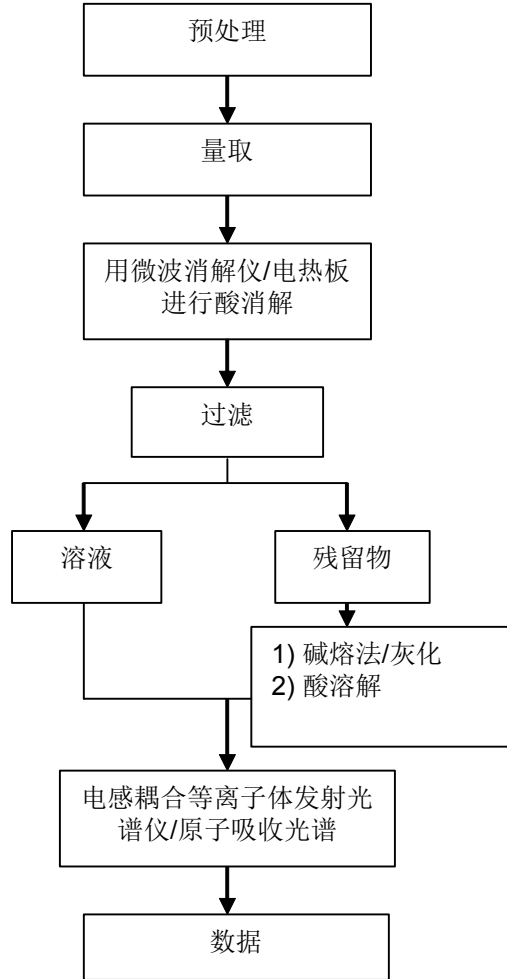

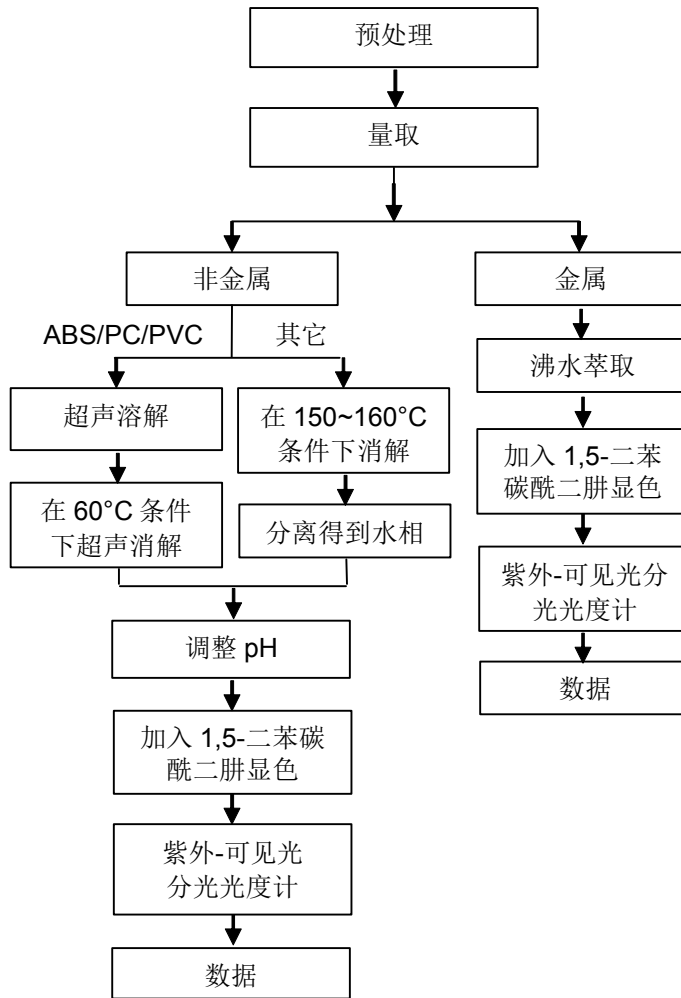
## 元素(IEC62321) 测试流程图

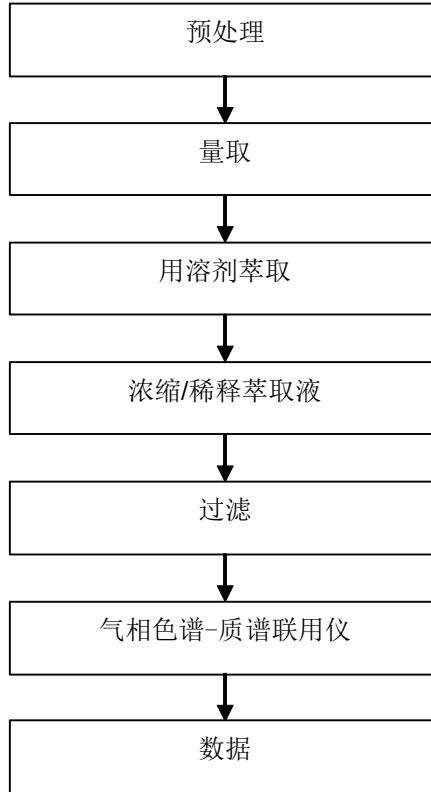
## 六价铬测试流程图

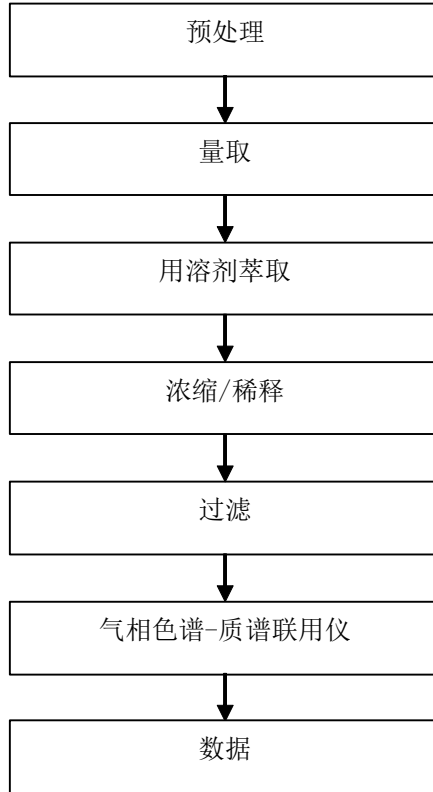
## PBBs/PBDEs 测试流程图

## Phthalates 测试流程图

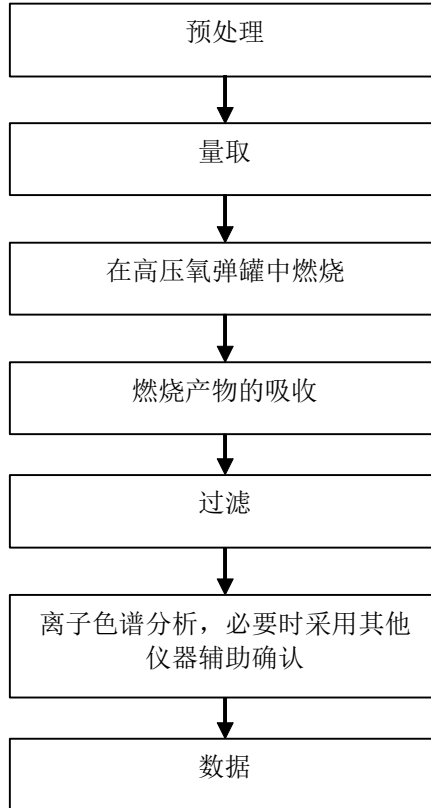

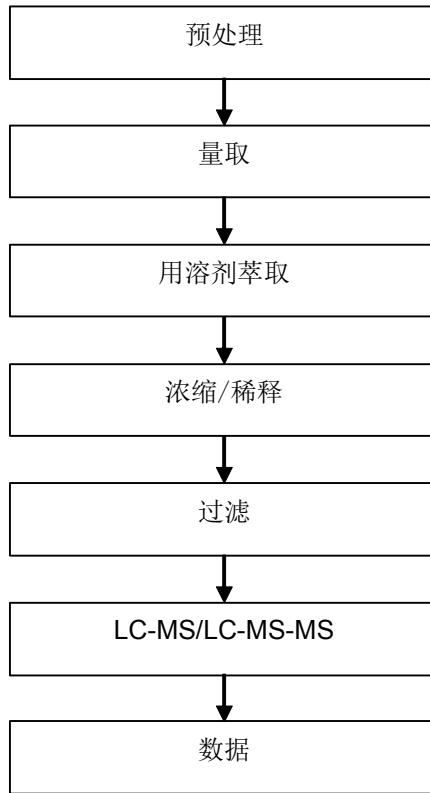
## Halogen(氧弹法)测试流程图

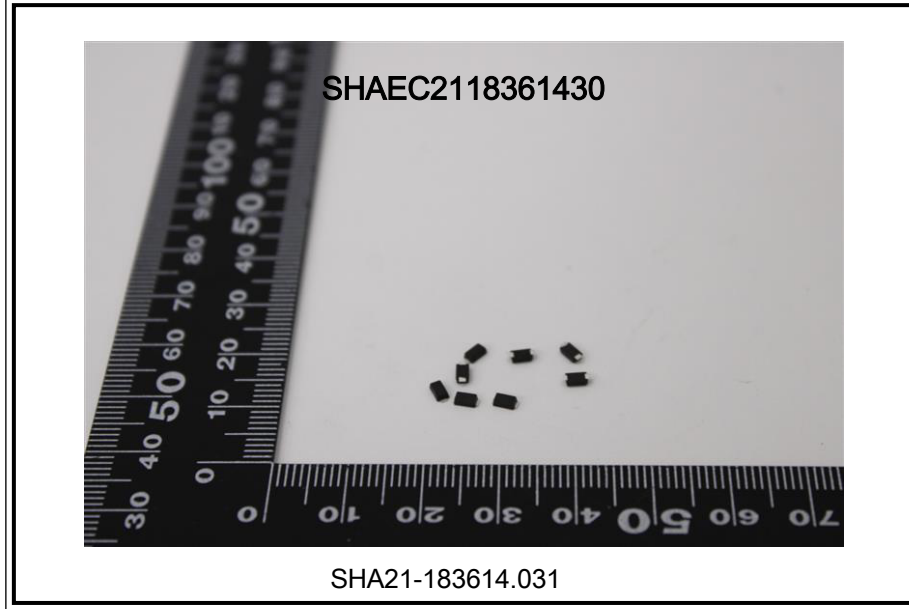
### PFASs/ PFOS/PFOA 测试流程图
